Conversion price: Baht 0.036 per share. The weighted average price of the Company's shares trading on the Stock Exchange of Thailand for not less than 7 consecutive business days but not exceeding 15 consecutive business days prior to the date that the Debenture holders exercised their conversion rights during Dec 26,2023 - Jan 8,2024 are Baht 0.04 per share. The conversion price is not less than 90 percent of the said weighted average price. Therefore, it does not meet the criteria to prohibit the sale of shares within 1 year from the date of receiving the convertible securities (Silent Period).

In this regard, the weighted average price is calculated from the volume weighted average price of the Company's shares for each consecutive business days (Floating Conversion Price). The market price will be calculated with two digit decimals while the conversion price will be calculated with three digit decimals.

The Company offered and issued the Convertible Debentures No. 18/2022, 1-6/2023 and 1/2024 on Mar 13, 2023 - Jan 5, 2024 at the amount of Baht 80 million (80,000 units). The Debenture holders exercised their conversion rights during Apr 4, 2023 - Jan 9, 2024 amounting to Baht 51 million (51,000 units). Total remaining Convertible Debentures No. 18/2022, 4-6/2023 and 1/2024 of Baht 29 million (29,000 units) has not been exercised.
