Conversion price: Baht 0.018 per share. The weighted average price of the Company's shares trading on the Stock Exchange of Thailand for not less than 7 consecutive business days but not exceeding 15 consecutive business days prior to the date that the Debenture holders exercised their conversion rights during Aug 1-9, 2024 are Baht 0.020 per share. The conversion price is not less than 90 percent of the said weighted average price. Therefore, it does not meet the criteria to prohibit the sale of shares within 1 year from the date of receiving the convertible securities (Silent Period).

From the resolution of the EGM 1/2023 on November 28, 2023, the weighted average price is calculated from the volume weighted average price of the Company's shares for each consecutive business days (Floating Conversion Price). The market price and the conversion price will be calculated with three digit decimals.

The Company offered and issued the Convertible Debentures No.1-8/2024 on Jan 5 - Jun 10, 2024 at the amount of Baht 80 million (80,000 units).The Debenture holders exercised their conversion rights during Feb 6 - Aug 13, 2024 amounting to Baht 67 million (67,000 units). Total Number of Convertible Debentures No. 6/2024 of Baht 10 million (10,000 units) has been fully exercised. Total remaining Convertible Debentures 7-8/2024 of Baht 13 million (13,000 units) has not been exercised.
